

ORDINANCE NO. 1 of 1980

Jefferson Township,
Lackawanna County,
Pennsylvania

AN ORDINANCE REGULATING THE PARKING OF MOTOR VEHICLES ON ROADS, STREETS AND RIGHTS OF WAY WITHIN THE TOWNSHIP OF JEFFERSON AND PROVIDING FINES AND PENALTIES FOR THE VIOLATION THEREOF.

Whereas, the Board of Supervisors of Jefferson Township has found, and does find, that the parking of motor vehicles on the township roads, streets and rights of way within Jefferson Township interferes with the efforts of the township to maintain said roads, streets and rights of way free and clear of ice and snow, in proper repair and free of congestion so as to insure the safety of the travelling public thereon.

Now therefore, in order to promote the public welfare and safety within the said township, BE IT ENACTED AND ORDAINED by the Township of Jefferson, Lackawanna County, Pennsylvania, as follows:

1. No vehicle shall be parked on any township road, street or right of way within the Township of Jefferson, AT ANY TIME.
2. The term " vehicle " shall include automobiles, trucks buses, motorcycles, wagons, farm wagons and carts.
3. The term " parked " shall include vehicles stalled or incapable of moving under its own power, or left unattended upon any of the aforementioned roads, streets or rights of way.
4. Any vehicle parked in violation of this Ordinance may be removed or towed away by order of the Chief of Police, or

by one authorized by the Chief of Police to do so, and the costs of removal and/or towing and/or storage of said vehicle is hereby imposed upon the owner of said vehicle.

5. Any person violating the provisions of this Ordinance shall, upon conviction thereof by summary proceedings, be fined not less than Twenty-five Dollars (\$25.00) plus the costs of prosecution. A new and separate offense hereunder shall be deemed to have been committed for each day that the violation continues.

ORDINANCE NO. I OF 2011

**AN ORDINANCE AMENDING ORDINANCE NUMBER 1 OF 1980 PROVIDING
FOR THE REGULATION OF PARKING ON DESIGNATED ROADWAYS**

WHEREAS, the Township anticipates development along Route 247 and Route 348 between the intersection of Routes 348 and 247 to the entrance ramp of Interstate Route 84; and

WHEREAS, the Jefferson Township Board of Supervisors have determined that parking along said Route 247 in the area as described above will cause congestion, reduce sight distances and impact overall safety of the traveling public.

NOW THEREFORE BE IT ENACTED AND ORDAINED by the Board of Supervisors of Jefferson Township, Lackawanna County, Pennsylvania and it is hereby enacted and ordained by the authority of the same as follows:

1. Ordinance Number 1 of 1980 is hereby amended to add the following:


<u>Name of Highway</u>	<u>No Parking Side</u>	<u>Location</u>
Route 247	Both Sides	From the intersection of Rt. 348 & Rt. 247 to the exit/entrance ramps of interstate Rt. 84

This ordinance shall take effect immediately.
